Declaration by Branch President

- 1. - 3. Rule 52ET of the Police Federation of Australia, New South Wales Police Branch Rules requires that notice of any proposed rule change is required to be given to each member of the Branch Executive at least one month prior to the relevant meeting of the Branch Executive. The Branch Executive may alter the rules by resolution carried by a 2/3rds majority of the Branch Executive
- 4. The meeting of the Branch Executive of the Police Federation of Australia, New South Wales Police Branch held on 5 April 2017, approved the alterations to the Rules of the Branch. The following motion was carried unanimously by the Branch Executive. A quorum was present.

PART CE - NEW SOUTH WALES POLICE BRANCH

Proposed Amendments to Branch Rule 52 EH (g)

1. Current Rule

52EH - BRANCH EXECUTIVE

(g) Scrutineers

Any candidate may if he/she so desires appoint a scrutineer who is a financial member of the Federation to represent him/her at the ballot. The candidate appointing the scrutineer shall, before the closing of nominations, notify the Returning Officer in writing of the name of such Scrutineer, who:-

- (a) shall be entitled to be present throughout the ballot and may query the inclusion or exclusion of any vote in the count, but the Returning Officer shall have final determination of any votes so queried;
- (b) shall not be entitled to remove, mark, alter or deface any ballot or other document used in connection with the election; and(
- c) shall not interfere with or attempt to influence any member at that time such member is casting his/her vote

Proposed Rule

52EH - BRANCH EXECUTIVE

(g) Scrutineers

Any candidate may if he/she so desires appoint a scrutineer who is a financial member of the Federation to represent him/her at the ballot. The candidate appointing the scrutineer shall notify the Returning Officer in writing of the name of such Scrutineer, who:-

- (a) shall be entitled to be present throughout the ballot and may query the inclusion or exclusion of any vote in the count, but the Returning Officer shall have final determination of any votes so queried;
- (b) shall not be entitled to remove, mark, alter or deface any ballot or other document used in connection with the election; and
- (c) shall not interfere with or attempt to influence any member at that time such member is casting his/her vote.
